
WHEREAS, pursuant to A.R.S. § 12-213, the Presiding Judge of the Superior Court has the authority to appoint court commissioners for the Superior Court,

WHEREAS, pursuant to A.R.S. § 8-231, the Presiding Juvenile Court Judge has the authority to appoint Juvenile Court Commissioners, and

WHEREAS Jeffrey S. Wohlford meets the qualifications for appointment as a Superior Court Commissioner pursuant to A.R.S. § 12-213 and the qualifications for appointment as a Juvenile Court Commissioner pursuant to A.R.S. § 8-231,

IT IS THEREFORE ORDERED appointing Jeffrey S. Wohlford as a full-time Pima County Superior Court Commissioner and a full-time Juvenile Court Commissioner to serve at the pleasure of the Presiding Judges of Pima County Superior Court and Pima County Juvenile Court, effective August 6, 2025 through June 30, 2026. Commissioner Jeffrey S. Wohlford's initial service on either Superior Court Family, Probate or Juvenile benches to be at the discretion of the Presiding Judge of the Superior Court and the Presiding Judge of the Juvenile Court.
